Financial results at 31.03.2023

n the first 3 months of 2023, the company achieved a turnover of 24,028,784 lei, significantly higher than the same period of the previous year, but as can be seen from the table below, a gross loss of 485,402 lei (on 31.03.2022 there was a gross loss of 1,650,894 lei) and a net loss of 558,204 lei (in the corresponding period of 2022, a net loss of 1,692,349 lei was realized).

In the period 01.01-31.03.2023, operational revenues, in the amount of 24,036,497 lei, increased compared to those recorded in 3 months in 2022 (2,463,900 lei), mainly due to the production program for this year, which provides the delivery of two new river ship constructions in the first quarter (there were no ship deliveries in the first quarter of 2022). Operational expenses, in the amount of 24,581,207 lei, and in close correlation with operational revenues, in the 3 months of 2023 also registered an increase compared to their level from the similar period of 2022 (4,115,965 lei).

From the financial activity, the company realized during this period a profit in the amount of 59,308 lei, much higher than the one realized in the similar 3 months of 2022 (1,171 lei).

In the period 01.01-31.03.2023 the company Santierul Naval Orsova S.A. recorded the following financial results:
