## Financial results at 31.03.2024

In the first 3 months of 2024, the company achieved a turnover of 18,492,460 lei, lower than the same period of the previous year, but as can be seen from the table below, on total activity a gross profit is recorded in the amount of 908,732 lei (on 31.03.2023, a gross loss of 485,402 lei was recorded) and a net profit in the amount of 666,758 lei (in the corresponding period of 2023, a net loss was realized in the amount of 558,204 lei).

In the period 01.01-31.03.2024, operational revenues, in the amount of 18,656,752 lei, decreased compared to those recorded in 3 months in 2023 (24,036,497 lei), mainly due to the production program for this year, which provides the delivery of a new river ship construction in the first quarter (two ships were delivered in the first quarter of 2023). Operational expenses, in the amount of 17,778,428 lei, and in close correlation with operational revenues, in the 3 months of 2024 also recorded a decrease compared to their level from the similar period of 2023 (24,581,207 lei).

From the financial activity, the company achieved during this period a profit in the amount of 30,408 lei, lower than the one achieved in the similar 3 months of 2023 (59,308 lei).

In the period 01.01-31.03.2024 the company Santierul Naval Orsova S.A. recorded the following financial results:
