## Preliminary financial results at 31.12.2025

The company Santierul Naval Orsova S.A., ended 2025 with financial results superior to the levels projected for this year.

- The company achieved a turnover of 126,096,950 lei in 2025, an increase of 23.37% compared to the same period of the previous year
- During the period 01.01-31.12.2025, operating income, in the amount of 125,125,701 lei, increased by 25.08% compared to those recorded in the corresponding period of 2024 (100,038,158 lei).
- Operating expenses, in the amount of 115,779,439 lei and in close correlation with operating income, recorded an increase in 2025 by 23.92%. compared to their level in the similar period of 2024 (93,432,551 lei).
- The profit achieved from the operational activity at the end of 2025 is 9,346,262 lei (in the corresponding period of 2024 a loss was recorded in the amount of 6,605,607 lei).
- From the financial activity, influenced by the evolution of the exchange rate, the company achieved in this period a profit in the amount of 1,068,634 lei, 14.14% higher than that achieved in 2024 (936,208 lei).
